Trustee Millett: Streetscapes bids are all in. The project should be finished by 2nd week of June. Trustee Millett met with Superintendent Parrow in reference to putting some sand to help level the playground for winter Ice skating rinks at Thomson Playground. Pickle ball and Tennis court lights are being addressed; they should be in before spring. The Village may want to consider raising rates for Pickle Ball and Tennis to offset the lighting cost.
