Trustee Strough: Interviews will be done this Thursday for Club House Attendants. Trustee Strough hopes to open the Golf Course the first or second week of April; weather permitting.

DPW Superintendent Parrow: Dive Park work has started and is being done through FEMA; The Chavoustie wall product has been delivered and will is able for chips disbursement. Cold patch has begun on the Streets. A water leak has been repaired on Church Street. Work has been done on Walton Street also. Holes will be patched once a manhole is fixed.
