**Discussion-**5:15 pm Sign Regulations for Village of Alexandria Bay, Andy Nevin was present with Russ Schroth, Larry Cullen, and Lee Shimel for the Comprehensive Plan.

Andy Nevin spoke to the Community and Board in reference to the Comprehensive Plan, he did a power point with different sign types.

Russ Schroth addressed the Board and Community also and explained the concept and explains how the Comprehensive plan would like to move forward. He also spoke of how the Sign Laws will be out of the Village Boards hands and moved to Planning and Zoning.

Open Public Hearing at 5:40 pm- Roger Reifensnyder spoke to the Board and Comp Group, he isn't happy with some of the wordage on the plan. He thinks that the plan is micromanaging the rules. He states window lettering restrictions are too stringent. Russ Schroth countered with the fact that the committee realizes most people follow the process but there are always a few who push the envelope. Nav's Popcorn spoke about a Village map that would help the public find other businesses besides just on the main streets that may be able to alleviate sandwich boards. Gary Williams spoke in reference to if any injuries from signage have ever been documented, he feels that signs lit are not distracting and businesses need the attraction due to the short season. He also feels the this plan will give too much control to the Boards. Russ Schroth stated that they measured the streets and only a few areas will be affected by the laws.

Loraine Schroth spoke of boards being made and offered to all businesses so visitors could check out every business with their wares or specials and that would alleviate the sandwich board issues.

**Public Concerns:** Harriett Madden who came to a meeting in December in reference to the Pavilion Restrooms and how they needed to be taken care of better. She states it's been wonderful this season to see how clean the restrooms are and the park conditions are also well improved.

Roger Reifensnyder spoke about parking concerns and discussions on parking on Church Street. Mr. Reifensnyder wants to make sure the Board is aware these are his feelings and not anyone elses. He spoke of River Hospital and parking issues. He supports the Hospital but feels they have some growing pains and what is the next steps for them? Is there an Urban Planning concept. There are 41 businesses in Alexandria Bay and most have no private parking. He spoke of re-routing the Ambulance's to alleviate the bottle neck issue on Church Street.

Ron Thomson spoke about patrons not wanting to park long distances from a shop or store. He agrees that taking parking spots away would hurt businesses. Trustee Derrigo addressed the community stating he is not trying to take parking away from anyone. But a problem needs to be solved and eliminate any issues for the Ambulances coming into the Village.
