Progress meeting was the 7th of September, next meeting is October 5, 2022 at 11am. Trustee Fulmer spoke on NY Forward, The Village has decided to not apply for this round of funding. The Village will move forward for the next round. The Village wants to have the whole application in acceptance order to include stakeholders before submission. The Water tower will be discussed in the next few days. Streetscape project railings have been ordered.

Pickle Ball Courts: Superintendent Parrow went and looked over the area for the courts Pickle Ball Courts. Mike Tibbles is away for the week and Greg Wills is getting a price for black top. When he has his figure's he will get with Trustee Demo.
