DPW Report: Superintendent Parrow is still waiting for word on the street sweeper. Market street will be fixed in the next few days now that events are not happening in that area. Work was done on Otter Street. 20 feet was repaired. Sand is being hauled for winter, they will move approximately 400 tons to the DPW complex.

Mayor Jarvis thanked the DPW for all its hard work with the summer events and all they have accomplished this summer.

Zoning Report: Tall grass was addressed. Mr. Shimel reiterated that the homeowner has 72 hours to comply after they receive a letter of deficit. After that a notice is given to the DPW to cut and the homeowners will be billed for the service. All complaints need to be on a complaint form or will not be accepted. Russ Schroth spoke in reference to the Comprehensive plan, and they hope to have for the Village Board review at the October meeting. They are asking the Board if they want them to hand over the plan compiled now and then proceed with the issues with short-term rentals. **Motion by:** Trustee Fulmer, seconded by Trustee Demo to approve submitting the Comprehensive Plan as it stands and then move forward with short term rentals after the first part is accepted, all in favor, Motion carried.

REDI/Streetscape:

Gregor Smith from BCA reports all that is left to do on the REDI is lighting on Riverwalk and running conduit. This process will start this week, weather permitting. Also, the ballard lights on the main dock and Lower James Street dock will be also finished up. Some railings will be put up next week and the handicap lift will be up and ready for spring. A meeting is scheduled for tomorrow at 9 am for NY Forward/DRI to finish out the application.

WIIA grant has been submitted and we should hear by late fall. NY Forward/DRI needs to be sent by 09/29/2023. The Village has a good application. Tim Maloney has been walking the Village and doing verification for Water Projects. New meters have been discussed for water accountability. Docks, Park/Pavilion, and a hydrant meter. Cemeteries are not metered also.

Street Scape: Holland Street ramp issues are being addressed. Once a letter of commitment has been received by the Town and Village of repairs at no cost to either entity, the Village will pay the balance of the contracted amount.
