Public Concerns: A concerned group of Village citizens from Catherine-Cornwall Streets and surrounding streets addressed the Village Board with concerns about speeding on Village Streets, especially on Catherine-Cornwall. Trustee Campany: Trustee Campany did a drive by the pavilion, and it looks good up there. He's thankful the curtains are staying up longer.

Trustee Demo: Halloween extravaganza is on October 28th. Flyers are out to merchants. Macsherry Library is getting ready for the craft fair December 2, 2023. HFY programs have started up for fall. Waiting lists are formed. The Golf Course is closed for the season. Trustee Demo is working on funding for pickleball. Gordon Courts has a new caretaker. United Helpers are very accommodating. Tree lighting is Friday, December 1,2023 with lighting trees at the Village. We are coordinating a group to help repaint and update some of the Village's decorations for the Christmas season. Hot cocoa has been donated for the event.

DPW: Market Street is fixed. Sand has been hauled for the season. The beach has been pulled. Cemeteries are shut down. Sidewalk work was done for Wagoner's. A tree in question was taken down.
