Susan Browning: spoke to the Village Board in reference to the Zoning changes and the effects changing from Marine Development to Single family residence would do. What is changing this going to benefit homeowners.

Russ Schroth: addressed concerns on the homeowners and the Zoning changes.

Pete Brown: from 21 Anthony called in and is concerned about the re-zoning. He stated that 6 people on his street should have been personally sent a letter on the zoning changes. He is concerned with changes.

Victor Willix: representing Victor Willix Sr. asked who Russ Schroth was and he didn't know anything about this until yesterday.

Brent Sweet: What are the hours and cost to the Taxpayers? Most of the work was done voluntarily and Lee Shimel has not had to ask for additional services. He works 2.5 hours a week. Uses that are going to change won't increase his demand. There was no direct cost from Jefferson County

Pam McDowell asked if Short Term rentals will be affected by this change and in the future will it affect them. Russ Schroth and Lee Shimel stated that rental cottages would not be allowed.

Trustee Caputo asked if in the old zoning, can places that are now running be changed. Lee Shimel explained that preexisting will be grand fathered in.

Trustee Fulmer asks if the other Zoning changes can be adopted, and the Anthony Street issue be voted on separately?

Attorney Burrows stated that the paperwork is a draft. The Village Board can vote to adopt or can tweak the Zoning Law. If changes need to be made, they can go and amend the Law that fit the needs of the community.
