Mayor Putnam – Present

**Mayor Putnam** - “Real quickly, a letter will be emailed to the Chamber next week. We have a CD at Community Bank that is up for renewal. I would like to maybe keep \$300,000.00 in a CD and set \$200,000.00 aside in a savings account. **Trustee Fulmer** - “Tina said that we do have the money in the budget that was set aside to do the bathrooms at the Chamber building.” **Mayor Putnam** - “I would like to set aside at least \$100,000.00 incase we need it. **Trustee Fulmer** - “Can we put \$400,000.00 in a CD and \$100,000.00 in a savings loan?” **Mayor Putnam** - “Yes, we can do that.” **Trustee Fulmer** made a motion to put \$400,000.00 in a CD at Community Bank and put \$100,000.00 in a savings account. Seconded by **Trustee Strong**. **ALL in Favor-Aye**.

**Mayor Putnam** - “Bill from Mr. Drake. It was our fault, but he does need to plug up the drain in the basement. **Trustee Strong** - “Back when I worked for the Village if your sewer isn’t plugged and it is open, then it is your problem. If he would have had it plugged, then he would have not had that problem.” **Trustee Fulmer** - “Can we send Mr. Drake a letter asking him to try and go through his homeowner’s insurance first, and then we will address it” **Mayor Putnam** - “Yes, lets send him a letter to try and put it through his homeowner’s insurance and make sure he gets the drain plugged.”

**Mayor Putnam** - “The Arch sign. I would like to have a motion to have Bill Gill do the Arch sign. We have a letter from Stewart signs saying they would not be able to do it. There is a 60% deposit for starting the work. The total to do the sign is about \$57,000.00 so the deposit would be around \$34,000.00.” **Trustee Fulmer** made a motion to hire Bill Gill to work on the Village Arch.” **Trustee Strong** seconded”. **ALL in Favor-Aye**.

**Trustee Fulmer**- “Just one more thing. The NY Forward agreement, Attorney Burrows looked it over and said it was all good to sign the agreement. So, next week I will have that for you to sign. We will still have to reach out to the people who signed up for it.”

**Trustee Millett**- Gregor just called me and we are meeting in Clayton 2/4/2026 at 10:00am to look at their control panel at their water/sewer plant. I told Gregor to make sure Pat was aware so he could meet us up there too.”
